- In November 2017, Swisscom launched the Open Banking Hub a secure platform exchanging digital information within the financial ecosystem.
- Swisscom operates the core banking systems of 80+ financial services providers.


GOALS & RESULTS

- Using the API Gateway and API Developer Portal for the Open Banking Hub bringing together banks, financial services and Fin-Techs/Start-Ups
- Operation of the API hub on two levels: API Sandbox for first trials and productive usage within Swisscom's secure IT infrastructure
- First use involved <u>Baloise Bank SoBa</u> and RegTech Start-Up <u>Apiax</u>

PLANNED

- Further facilitating the pairing up of financial services with API-based FinTech products
- Offering a bullet-proof and standardised security mechanism across all services






